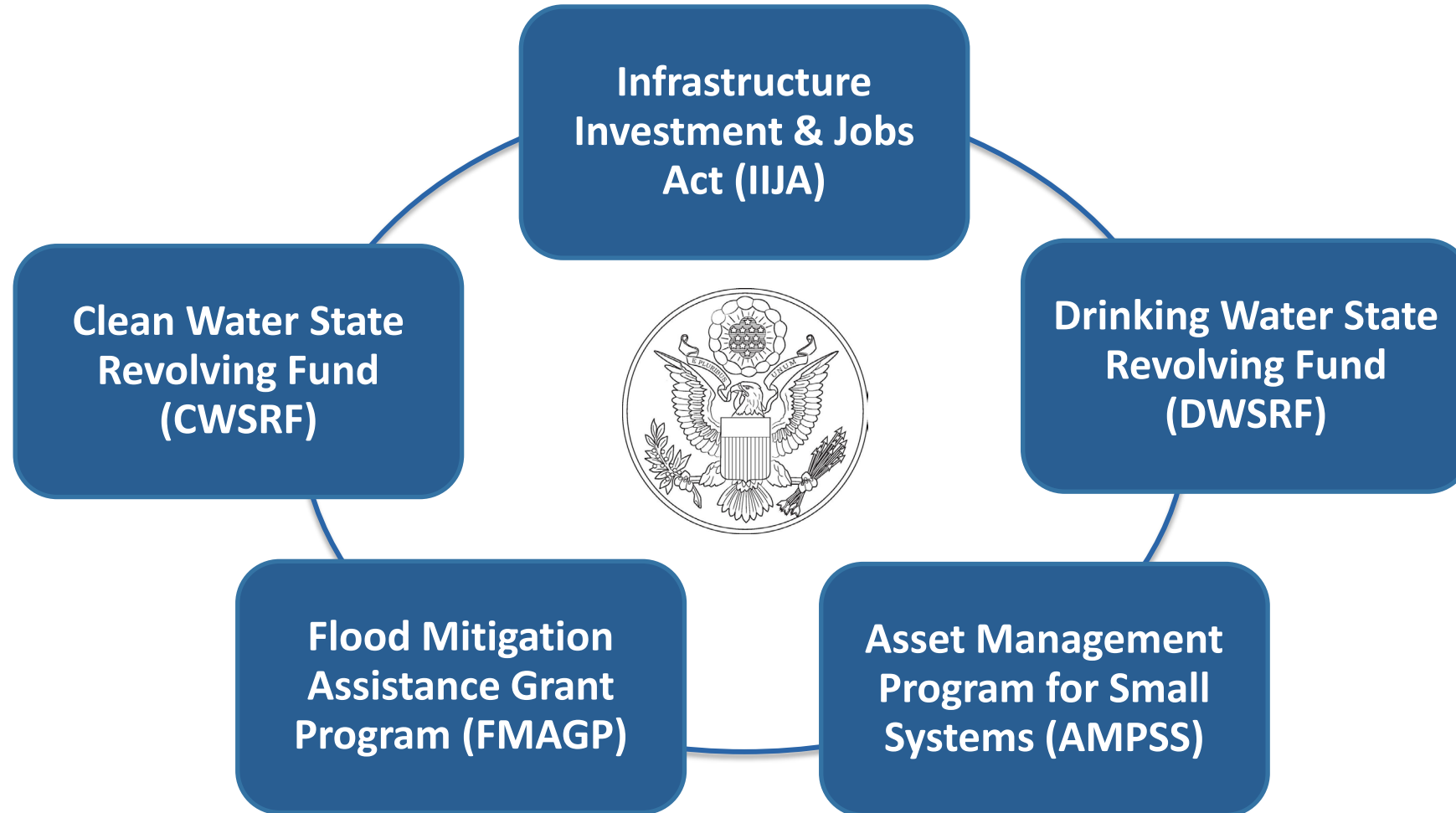
State Funded Financial Assistance Programs



State Water Implementation Fund for Texas

- SWIFT Fund
 - Initially funded with \$2 billion
 - Balance = ~\$1.7 billion
- Goal - \$27 billion in water supply projects over 50 years
- 2023 Cycle
 - 8 applications
 - \$1.5 billion in requests
 - July 25, 2023, Board Meeting

Regional Flood Planning

- First-of-its-kind statewide flood plan
- Watershed-based planning regions
- Bottom-up approach to flood planning
- Transparent process with public input
- Volunteer members representing interest categories

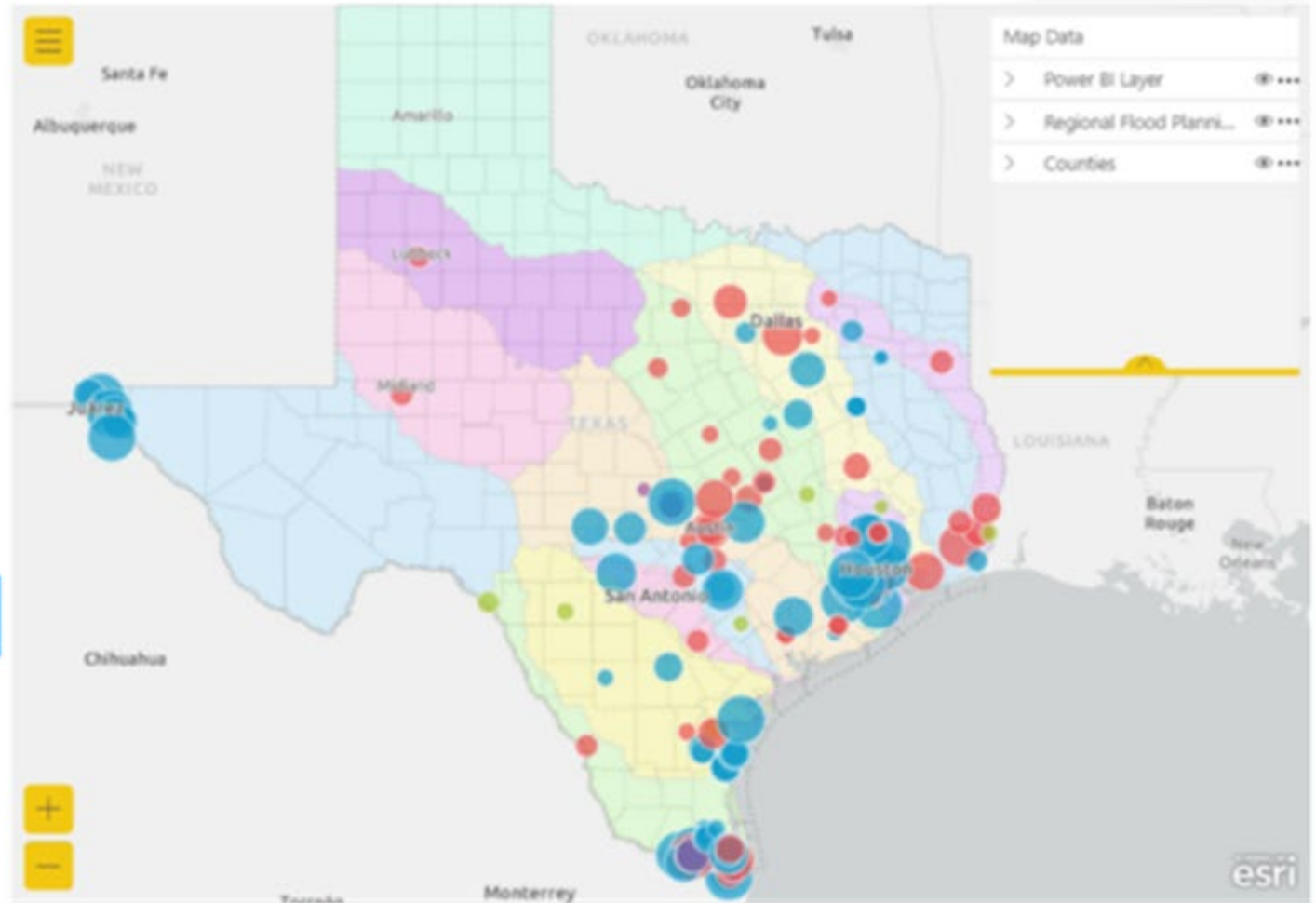
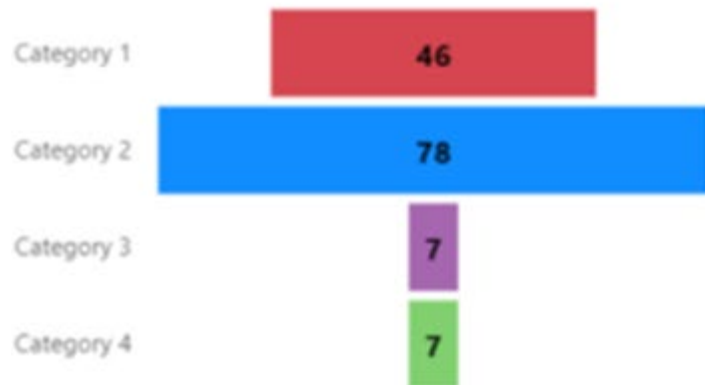
